Dear Mr. Lee:

The Texas Department of Family and Protective Services (DFPS), Children's Protective Services (CPS) Division, is pleased to provide this Letter of Commitment (LOC) to the Heart of Texas Homeless Coalition (HOTHC), the Continuum of Care (CoC) Collaborative Applicant for TX-604 Waco/McLennan County CoC in its application to the Housing and Urban Development (HUD) for the Youth Homelessness Demonstration Program (YHDP) grant. DFPS understands that this lucrative grant will support up to 25 communities with between \$1 million and \$15 million in funding (depending on population size and poverty level) in order to create and implement a Coordinated Community Plan to Prevent and End Youth Homelessness. We also understand that a threshold requirement of the grant is collaboration with a state or local Public Child Welfare Agency (PCWA). The CoC must include the state or local PCWA as a CoC member and must confer with the PCWA concerning the development of the community's application for the YHDP. Please let this LOC serve as verification that DFPS is a member of the CoC and ensure our commitment to participate in the creation of the Coordinated Community Plan.

DFPS input is vital to creating a Coordinated Community Plan to Prevent and End Youth Homelessness and the submittal of this grant application on behalf of the CoC of TX-604 Waco/McLennan County CoC. In addition to this LOC, DFPS agrees to execute a memorandum of understanding at the time funding is received between DFPS/CPS and HOTHC/the CoC outlining the following:

DFPS is a member of the Continuum of Care, which meets bi-monthly to discuss issues
regarding the homeless community. The HOTHC General Membership serves as the
primary source of expertise and program implementation. Responsibilities include
providing input, expertise, and recommendations to HOTHC and the HOTHC Board
regarding all matters relating to Continuum of Care responsibilities, policies, and
procedures.

- DFPS will commit to sending a representative to attend any meetings that relate to the development process of the application to be submitted to HUD by HOTHC.
- The DFPS representative will attend the monthly YHDP Leadership Committee meetings as required by HUD and listed in the Notice of Funding Announcement to oversee the development and planning effort to create and establish a Coordinated Community Plan to Prevent and End Youth Homelessness.
- The DFPS representative will provide input on the development and implementation of the Coordinated Community Plan to Prevent and End Youth Homelessness.
- The point of contact for the CoC is Staci Love, Regional 7 Program Administrator.

HOTHC agrees to:

- Integrate recommendations made by DFPS in the Coordinated Community Plan to Prevent and End Youth Homelessness.
- Rally community and programmatic support behind youth aging out of foster care and include these youth in future funding to end youth homelessness in the CoC region.

We understand that future YHDP program recipients will assume full responsibility for all match funds associated with the grant and that DFPS funds are not a part of the proposed match. We look forward to continuing our collaboration with HOTHC, the Continuum of Care Collaborative Applicant for the TX-604 Waco/McLennan County CoC, as a member of the CoC to improve outcomes for children and families experiencing homelessness in Texas.
